2) **RVML Resource Center ("RVML")**, the event promoter and producer, an Oregon non-profit corporation and federal tax-exempt 501(c)(3) organization.

The parties hereby agree on the following terms and conditions by which RECORDINGS of the PRESENTATION delivered by the PRESENTER on the date and with the title indicated above may be distributed. This agreement, between the "PRESENTER" and "RVML" will establish that:

The PRESENTER permits RVML to electronically record the lecture and/or workshop PRESENTATION(S) presented by the PRESENTER at RVML's event facilities in Ashland, Oregon, USA, or at such other suitable public facility where the PRESENTATION will be delivered.

The PRESENTER further agrees that RVML may use any images and/or text provided by the PRESENTER in connection with the PRESENTATION for the marketing and promotion of the PRESENTATION and subsequent RECORDINGS. RVML shall be entitled to use such images and/or text in whatever form RVML determines, at its sole discretion, at no cost.

The PRESENTER represents and warrants to RVML that the PRESENTER is the owner of any and all copyrights, trademarks or other intellectual property rights contained in the PRESENTATION, or that the PRESENTER has obtained the appropriate permission from the owner of any such intellectual property rights for the use of any such materials in the PRESENTATION in excess of the allowances stipulated in the Fair Use clause of Copyright Law Chapter 17. The PRESENTER hereby agrees to indemnify and hold RVML free and harmless from any claims for damages that may be made by the holder of any copyrights or other intellectual property rights incorporated in the PRESENTATION.

RVML will provide all of the necessary equipment and personnel, and may, at the discretion of RVML pay all miscellaneous expenses related to the recording and production of the PRESENTATION in order to make the RECORDINGS available for public use and/or purchase. In the case of unforeseen circumstances preventing the recording of the PRESENTATION (e.g. technical failure) or a decision by RVML to not produce media from the recording; the PRESENTER will hold RVML free and harmless and not liable for any claims in any instances of failure to produce a RECORDING of the PRESENTER'S PRESENTATION.

The PRESENTER retains the sole exclusive ownership rights to the informational content contained within the RECORDINGS.

The PRESENTER authorizes RVML to include copies of the PRESENTATION RECORDINGS in RVML's lending library collection (at the discretion of RVML's Library Manager).

The PRESENTER grants to RVML a perpetual, non-exclusive license to duplicate, distribute and/or broadcast audio and video RECORDINGS of the PRESENTATION including but not limited to audio cassette tape, audio CD, VHS videotape, DVD, broadcast, internet, MP3 and other multimedia formats produced, manufactured and distributed by RVML, in total or in part, without any financial compensation by RVML to the PRESENTER. PRESENTER further authorizes RVML to permit royalty-free end-user duplication and distribution of the PRESENTATION for educational, noncommercial purposes, as deemed appropriate by end-users.

If the presentation is selected for production, the PRESENTER is permitted to purchase and distribute an unlimited quantity of direct-to-retail copies of their RECORDINGS manufactured by RVML, at wholesale quantity pricing. The PRESENTER is required to distribute such RECORDINGS in their original, complete form as produced by RVML without editing or excerpting, and not in combination with other programming, without specific written permission from RVML, except as specified in the following paragraph.

The PRESENTER retains a perpetual, limited distribution license to their PRESENTATION RECORDINGS, and is permitted to duplicate and distribute a maximum of twenty (20) copies, in any combination of formats, during any one-year period, beginning on the date of the original recording, using only DVD or CD masters purchased from RVML. The PRESENTER is not permitted to provide RECORDINGS of the PRESENTATION to third-party distributors without specific written permission from RVML.
